A certified copy of this Order shall be provided to the Petitioner and the Sheriff of the issuing county. ANY LAW ENFORCEMENT OFFICER HAS THE DUTY TO ENFORCE THE TERMS OF THIS ORDER.

This Order shall be submitted to the Mississippi Protection Order Registry.

Only the Court can modify, change or dismiss the provisions of this Order. Neither party can modify or change this Order without the Court's approval. Petitioner/Protected Person(s) CANNOT waive the terms of this Order or give Respondent permission to violate the Order.

**NOTICE TO RESPONDENT**

- Any knowing violation of this Order may subject you to arrest and prosecution for a misdemeanor and punishable by a fine of up to \$1000.00 or by confinement in jail for as long as 6 months, or both. This Order is enforceable by all Mississippi law enforcement officers, and law enforcement officers from any other U.S. State, U.S. Territory or Tribal Territory.
- As a result of this Order, it may be unlawful for you to possess or purchase a firearm, including a handgun or long gun, or ammunition pursuant to federal law under 18 U.S.C. 922(g)(8) [and/or state, tribal, territorial or local law]. If you have any questions whether these laws make it illegal for you to possess or purchase a firearm, you should consult an attorney.
